Re: **Notice of representation of permanent residents in proceedings on the revocation of status in Israel**  
**Dwayat, ID No.**  
**Abu Kaf, ID No.**  
**Atrash, ID No.**  
**Abu Ghanam, ID No.**

The families, the details of whose sons are in the above reference (hereinafter: our clients), have authorized the attorneys of HaMoked: Center of the Defence of the Individual to handle the affairs of their family members, relating to the proceedings to revoke their status in Israel. Powers of attorney on behalf of the four families are enclosed herein.

1. Given the above, I wish to draw your attention to the following things:
2. Yesterday, October 21, 2015, it was reported in various media outlets that the Minister of Interior had signed letters of summons to a hearing that would be held for our four clients, whose details appear above. This, in the framework of proceedings initiated to revoke their status in Israel. Additionally, and according to the same media reports, the purpose of the hearing is to allow our clients to raise their arguments against the intention to revoke their status, prior to final decision in their case.
3. Until this writing, the families have not received summons or notice of the intent to summon our clients to a hearing.
4. Moreover, insofar as the media reports are accurate, and in order to ensure that the right afforded to our clients to present their case will be more than just an empty gesture, we request the following:

- That copies of the summons for the separate hearings that have been scheduled or will be scheduled for our clients be delivered to us as urgently as possible.
- That the exact schedule of the different hearings be assigned reasonable dates, that would allow our clients and us to hold adequate preparations ahead of time; and this also in order
