## **ISRAEL DEFENSE FORCES**

### **Order Regarding Defense Regulations (Judea and Samaria) (No. 378), 5730 – 1970 Regulations Regarding Permanent Resident in the Seam Area Permit**

Pursuant to my authority as head of the Civil Administration, and in accordance with Sections 5(A) and 7 of the Proclamation Regarding Closing of Area No. 7 /2/03 (Seam Area) (Judea and Samaria), 5764 – 2003 (hereinafter – the proclamation), I hereby order as follows:

#### **Definitions**

1. In these regulations:

“**seam area**” – as defined in the proclamation.

“**competent authority**” – the heads of the Israeli civilian Coordination and Liaison Offices.

“**permanent-resident permit**” – a written permit, issued by a competent authority, stating that the permanent residence of the holder is in the seam area.

“**the committee**” – a committee that will be established by me to examine requests to obtain a permanent-resident permit.

#### **Issuance of permanent-resident permit**

2. A. A permanent-resident permit shall be issued by a competent authority:
1. to a person lawfully in the region who is 12 years or older at the time that the proclamation takes effect and as to whom it is proven to the satisfaction of the competent authority that he is a permanent resident in the seam area at the time that the proclamation takes effect, provided that he submitted a request to obtain a permit within one year from the time that these regulations take effect or prior to his reaching age 16, whichever occurs later.
  2. to a person lawfully in the region who holds a permit for a new resident in the seam area, as set forth in Section 6 of these regulations, and as to whom it is proven to the satisfaction of the competent authority that he has resided permanently in the seam area for more than two years.

3. to a person lawfully in the region who is 12 years or older at the time that the proclamation takes effect and is registered as an accompanying individual in the permanent-resident permit issued pursuant to Subsections (1) and (2), provided that a request to obtain a permit is submitted before he reaches age 16.
- B. A permanent-resident permit shall be issued for a period set by a competent authority, in accordance with procedures that will be established.

**Request for permanent-resident permit**

3. A request to obtain a permanent-resident permit shall be submitted on a form titled “Request for Permanent Resident in the Seam Area Permit,” as set forth in Part 1 of the annex to these regulations.

**Examination of the request for permit**

4. A. Where a request for a permanent-resident permit is submitted, the competent authority may:
  1. Approve the request based on the request.
  2. Transfer the request to the committee for examination.
- B.
  1. In examining the request to obtain a permanent-resident permit, the committee may conduct any examination that it requires, including summoning the applicant to appear before it, and to order that any document necessary to examine the request be submitted.
  2. The committee shall not reject the request to obtain a permanent-resident permit unless the applicant is given an opportunity to present his arguments to the committee.
  3. Where the committee decides to approve the request to obtain a permanent-resident permit that was examined by it, the competent authority shall issue a permanent-resident permit to the applicant.
- C. A competent authority may, until completion of the examination of the request to obtain a permit, issue a temporary permit to the applicant to enter and stay in the seam area, for the period and according to the conditions that it shall set.

### **Renewal of the permanent-resident permit**

5. A. A competent authority shall renew a permanent-resident permit issued to a person as to whom it is proven to its satisfaction that he is a permanent resident in the seam area at the time of renewal of the permit.
- B. Where it is not proven to the satisfaction of the competent authority that the applicant for the renewal is a permanent resident in the seam area at the time of renewal of the permit, the request shall be forwarded to the committee for review; the committee's review shall be governed by subsections (B) and (C) of Section 4, with the relevant changes.

### **New resident in the seam area**

6. A. A person who is not a permanent resident in the seam area and requests to reside in the seam area shall submit a request to the competent authority to obtain a new resident in the seam area permit, on the form titled "Request to Obtain New Resident in Seam Area Permit," as set forth in Part 2 of the annex to these regulations.
- B. The request shall be examined by the committee in accordance with the provisions of Section 4(B).
- C. Where the committee approved the request, the competent authority shall issue to the applicant a permit for a new resident in the seam area, for a period of one year; a request to renew the new-resident permit shall be governed by the provisions of Section 5, with the relevant changes.
- D. A new resident who has permanently resided in the seam area for two years at least may submit a request to obtain a permanent-resident permit, in accordance with the provisions of Sections 3 and 4, with the relevant changes.
- E. A competent authority may, until completion of the examination of the request to obtain a new-resident permit by the committee, issue a temporary permit to the applicant to enter and stay in the seam area, for the period and according to the conditions that it shall set

### **Publication**

7. A. Copies of these regulations shall be deposited for public review during normal working hours of the following offices:

1. The sector Coordination and Liaison Offices.
2. Police stations in Judea and Samaria.
3. The office of the legal advisor for Judea and Samaria.
4. Offices of the head of infrastructure in the Civil Administration for Judea and Samaria.

B. Copies of these regulations shall be posted on the bulletin board in the sector Coordination and Liaison Offices, as stated in Subsection (A)(1), for a period of three months from the day that these regulations take effect, or shall be published in any other manner that I shall determine.

**Commencement of validity**

8. These regulations shall take effect on the day they are signed.

9. These regulations shall be called: "Regulations Regarding Permanent Resident in the Seam Area Permit (Judea and Samaria), 5764 – 2003."
